Key Learnings

The training broadened my horizons in agricultural extension. As a fisheries extensionist, I gain exposure to emerging competencies, global opportunities, and innovative approaches. The emerging competencies, such as facilitation skills, digital competencies, and innovation management were highlighted as indispensable for modern extension professionals.

I learned how next-generation competencies like visioning, research priorities, and democratization of innovations will shape the future extension landscape by 2050. Exposure visits to incubation centres, particularly RKVY-RAFTAAR, underscored NAAVIC. under the vital role entrepreneurship, sustainability models, and startup ecosystems in agricultural transformation. The critical sessions on gender mainstreaming reaffirmed the central role of inclusivity in shaping extension systems and research priorities. The research and methodology tools, such as Monitoring & Evaluation (M&E) frameworks and structured Focus Group Discussions (FGDs), strengthened methodological competence for research and field engagement.

Training Experience

The programme blended conceptual, experiential. and practical learning seamlessly. Participatory activities like the World Café, Extension Marketplace, and Commitment Cards stimulated critical thinking and creativity. Field exposure to incubation centres provided real-world insights into startup culture and its synergy with agricultural extension.
