

**Mr. Mangesh Nevchand Chaple** is a resident of village Ganeshpur Tal. Armori, Dist. Gadchiroli and his family consist of parents, younger brothers, wife and two daughters. In addition to working in his own farm, also works as a labour on daily wage earns Rs. 2000/- per month. He owns 4 acres of farm land. He grows paddy, Redgram and sesame as the major crops in kharif in his field and chana, jawas, peas, lakhori and other vegetable crops during Rabi season.



He owns two buffaloes, two cows and 3 goats. He extract good amount of dung and uses it in the farm. In his village a cluster have been formed across 50 acre which includes 42 farmers who have started practicing Organic farming. Among the 42 farmers, Mr. Chaple started organic farming from 2016. They used 'Dhencha' as a green manure for rice crop and used two quintals of vermicompost, compost and jeevamrut every 20 days of regular interval and for controlling pest and diseases use Agniashtra, Brahmashtra, Dashparni ark.

Guidance and training was provided for the preparations of organic fertilizers and pesticides by ATMA Gadchiroli, under the traditional agriculture scheme. From time to time soil and food testing was done through ATMA and certification through PGS,with the help of ATMA. Mr. Chaple and his younger brother managed the sales. The goods were sold at Nagpur, Akola, Pune, and other places of Maharashtra and also in local market. ATMA Department and Mrs. Priti Sonkusare CFA trainee Organic Farming provided advices to Mr. Chaple and his group of Farmers from Sowing to harvesting of the crop, pest and diseases individually or by Organizing meetings.

Mr. Chaple wants to convey message to all farmers that organic farming is the need of the hour to double the productivity of the farmers, to reduce the cost of cultivation and to keep the good soil health in turn to keep our health strong.
