National Level workshop on "Capacity building of Facilitators of DAESI Program"

National Level workshop on "Capacity building of facilitators of DAESI Program" was held on 13-14 July, 2023 in Hindi language at National Institute of Agricultural Extension Management (MANAGE) Hyderabad Focusing on monitoring and implementation of DAESI program. The workshop was organized for facilitators and State Nodal Officers of DAESI program. 43 Participants from 10 States i,e. Bihar, Chhattisgarh, Maharashtra, Madhya Pradesh, Odisha, Punjab Rajasthan, Uttar Pradesh, Uttarakhand and West Bengal attended the workshop in Hindi language.

Dr. Mahantesh Shirur, Deputy Director, Agricultural Extension and Principal Coordinator, DAESI welcomed chief guest Dr. P. Chandra Shekara, Director General, MANAGE and all the participants for the two days national level workshop. He presented the progress of DAESI program in the last three years and mentioned the objective of the workshop as to orient and to train the facilitators to become master trainers and sensitize all other facilitators about good practices and guidelines of DAESI program implementation through organizing State level workshops.

Inaugurating the national workshop, Dr. P. Chandra Shekara, Director General, MANAGE delivered the key note address. DG MANAGE recollected the origin and progress of DAESI program during the last 20 years. So far, 71,342 input dealers were trained and another 22,400 input dealers are being trained at present. He also highlighted major initiatives undertaken in the past year to make the DAESI program relevant in the light of national priorities and need for farmers' prosperity.

The workshop was planned under 7 technical sessions to cover different aspects of effective DAESI program implementation. On day one, an ice-breaking session was held and the candidates brainstormed on their expectations about the workshop. The participants of the workshop were divided into five groups of five facilitators each along with three nodal officers in each group and were asked to name their group and to identify

their group leader. The ice-breaking exercise helped the participants to break their stereotypic thinking and to express their views without any hesitation to their group members.

To orient the facilitators on best record management practices, a session on maintenance of DAESI records: cross learning among the participants was designed. The major learning objective of this session is to create awareness on importance of record writing by Input dealers in learning, to understand the facilitator role in record keeping and to come up with standard evaluation criteria of records.

The third session on Hands on training on preparation of annual session plan was conceived with the learning objective to orient the facilitators to plan the sessions according to course curriculum for better learning experience to know the importance of sequence of classes to be planned to enhance adult learning and to have a synchronous learning of theory class room sessions with practical classes/skill practice. The session was handled by Ms.Kanchan Bhagwat and Dr. Manunayaka.G

The fourth session was on MIS of DAESI which was designed with an objective to orient the participants about the functioning of MIS system and to teach them about Do's and Don'ts while entering the details in the MIS Portal. Dr. Naveen Kumar Gattupalli, Academic Associate, MANAGE, demonstrated the stepwise handling of MIS portal.

The technical session 5 was designed to make the facilitators acquainted with writing effective success story and to provide them stepwise guidance in writing the success story. Dr. Tanya Saklani and Dr. Shilpa B. handled the session guiding the participants about various aspects of designing, writing and publishing an ideal success story.

The objective of the session on Hands on training on financial management and record keeping



session is to orient the facilitators and SAMETI officers on importance of "Book Keeping and Accounting"function, Books of accounts to be maintained at various levels and their purpose and guidance in timely submission of AUCs to MANAGE. The session was handled by Mr. Rajendra Babu, Consultant (Finance), MANAGE.

demonstration on the Q-sort technique to the facilitators.



Success Story: DAESI – A mechanism for scientific crop advisory to the farmers

Ramakant Singh, started agri-input venture "YARA CROP NUTRITION CENTRE" in NAYA BHOJPUR, Block-Dumraon, Distt — Buxar, Bihar in the year 2017. He enrolled into Diploma in Agriculture Extension Services for Input Dealers (DAESI) in the year 2021-22 at ATMA, Buxar. Previously, he had retail business of pesticides and seeds and after DAESI training, the venture was expanded to include fertilizers also

Before the DAESI training he was unsure of advising farmers on crop production and management. After getting trained under DAESI, he learnt various practices on production technology of cereal crops, vegetables and fruits, Mushroom production, Bee keeping, Organic farming, Seed act and Integrated Pest Management, Schemes of department of agriculture, horticulture etc. He started working as an active para extension worker in the dissemination of agricultural knowledge in the surrounding areas and started attracting more farmers to his shop by. Farmers in the area who were completely dependent on chemicals to control insect/pest became aware of organic farming and Integrated Pest Management practices. DAESI training has significantly increased the income as well as enhanced the technical competency of Mr. Ramakant Singh which indirectly made him opinion leader in the eyes of the farmers. Mr. Singh expressed his gratitude to DAESI programme and also thanked ATMA Buxar for their efforts in educating the input dealers in a righteous manner.


Good practices in implementation of DAESI programme

- Sketch records
- Feld visits records
- Problem solution register
- Herbarium collection (combination of pest, disease and weed management)
- Assignment write-ups
- Success story of input dealers as para-extension workers




Verification of DAESI records by MANAGE Consultant (DAESI)

These records serve as repository of knowledge for the input dealers even after completion of the DAESI course. They provide information on important crop diseases, major pests and insects, dangerous weeds, kind of problems faced by farmers in the region, etc. DAESI brings together on a single platform input dealers, extension functionaries, scientists as well as progressive farmers and establish a network which is necessary for exchange of information and dissemination of technologies. Through institute visits and field visits the DAESI programme enlightens them about different agriculture institutes working in the region and to make use of services provided by these institutes.

One of the Training institute in Karnataka has made commendable efforts in implementing the DAESI programme with innovative ideas and practices.

The facilitator, Mr. A. V. Purushotam handling DAESI batches in Chitradurga, Shivamogga and Davangere districts from 2016 is setting examples for implementing such good practices in DAESi program implementation.






