Procedure for issue of duplicate Certificate of DAESI

- 1. The candidate should submit the duly filled in application form for issuance of Duplicate Certificate.
- 2. Along with the application, the following documents have to be enclosed:
 - a) An affidavit in a prescribed proforma on Non-Judicial stamp paper worth of Rs.50/- to be attested by Notary / 1st Class Magistrate.
 - b) Evidence of proof of completing DAESI program.
 - c) Aadhar number of the candidate (copy to be enclosed).
 - d) Two Passport size photos
 - e) Demand Draft of Rs.2000/- drawn in favour of "MANAGE" payable at Hyderabad.
 - f) If the damaged DAESI certificate is available with details of I.D. Number, Name of the Candidate, Father's name and year of examination are legible, it may be sent to this office along with the application, in such cases affidavit is not required.
