## SCHEME

The scheme aims to supplement the financial needs of all landholding farmers' families in procuring various inputs to ensure proper crop health and appropriate yields, commensurate with the anticipated farm income as well as for domestic needs. Under the Scheme an amount of Rs.6000/- per year is released by the Central Government online directly into the bank accounts of the eligible farmers under direct benefit Transfer mode, subject to certain exclusions. The funds are sanctioned in equal installments of the amount Rs. 2000 thrice a year.

### **Eligibility criteria**

- The scheme is applicable for only the small and marginal agricultural farmers.
- Rural as well as urban farmers can apply.
- The net land ownership must not be more than the land area of 2 hectares.
- Agriculture households possessing the cultivable land are also entitled for the scheme benefits.

### **Some Exclusions**

The following categories of beneficiaries of higher economic status shall not be eligible for benefit under the scheme

- (a) All Institutional Land holders; and
- (b) Farmer families in which one or more of its members belong to following categories:
- 1) Former and present holders of constitutional posts
  - 2) Former and present Ministers / State Ministers and former / present Members of Lok Sabha / Rajya Sabha / State Legislative Assemblies / State Legislative Councils, former and present Mayors of Municipal Corporations, former and present Chairpersons of District Panchayats.
  - 3) All serving or retired officers and employees of Central / State Government Ministries / Offices / Departments and their field units, Central or State PSEs and Attached offices / Autonomous Institutions under Government as well as regular
  - 4) All superannuated / retired pensioners whose monthly pension is Rs.10,000/- or more (Excluding Multi-Tasking Staff / Class IV / Group D employees)
  - 5) All Persons who paid Income Tax in last assessment year.
  - 6) Professionals like Doctors, Engineers, Lawyers, Chartered Accountants, and Architects registered with Professional bodies and carrying out profession by undertaking practices.
