1. Agriculture Support Schemes

1.1. AGR 2 (Farm Mechanization) scheme of farmers other than SC/ST

OBJECTIVE

There is a lot of shortage of agricultural laborers due to industrialization and urbanization in the state. It is imperative to expand the agricultural mechanization to make the agricultural industries successful, with a low cost and more farm production. The farmer can get good quality and more farm produce at low cost by maximizing and utilizing natural, unimplemented sources such as land, water and atmosphere due to agricultural mechanization. Thus, in order to increase the agricultural mechanization, assistance is given under the AGR 2 (Agricultural Machinery) scheme, in 208 talukas of state where Centrally Sponsored "Submissions on Agricultural Mechanization" scheme is not implemented.

100% state sponsored scheme

Eligibility Criteria

Any farmer of state other than SC/ST (in 208 talukas where SMAM scheme is not implemented) are eligible under this scheme.

The beneficiary farmer must purchase from the authorized manufacturer of the included manufacturer in the panels prepared for the purpose of periodic disclosed prize discovery by the Agri. office/department

1.2. AGR-3 Distribution of Seeds and fertilizer at subsidies etc. to Adivasi farmers in Tribal Area (TASP)

OBJECTIVE

The Government is trying to get the higher production of the agricultural crops of the farmers belonging to scheduled tribe and the tribal cultivator residing outside tribal area to improve their livelihood.

The main object of the scheme is to maximize farmers attempt to buy and use the Plant protection equipment, Tarpaulin, Field Demonstration, Micronutrient, Open pipeline, Agriculture fair, Underground pipeline, Organic Fertilizer, Pump set, premium for Farmers accidental insurance scheme etc. for increase the crop production according to scientific recommendations so they can get higher production of the agricultural crops and their by it improve their livelihood.

Eligibility criteria

The scheme is only for the ST farmers.

Benefits of the Scheme

In the areas of Talukas (Blocks) and Districts which are benefited/added under the Agriculture Support Program in Tribal Area Sub Plan & Dispersed Tribes (TASP) can get the benefit of this Scheme.
