Amarender Reddy, RTI applicant, Flat No.402, H.No.11-6-360, Vijay Residency, Cherukuthota Colony, Saroornagar – 500035 were directed to appear on 2<sup>nd</sup> April, 2019 at 10.00 a.m. before the First Appellate Authority of MANAGE under RTI Act, 2005 vide letter No. MNG-01/Admn-196/16-17/32444, dated 20/03/2018 for disposal of the appeal Registration No. NIAEM/A/2019/60001, dt.06/03/2019 raised by Dr. A. Amarender Reddy.

The CPIO, MANAGE and Dr. A. Amarender Reddy, RTI applicant attended the hearing before the Appellate Authority on the specified date and time.

#### RTI applicant sought following information:

Online RTI application No. NIAEM/R/2019/50001, dated 21/01/2019.

**Information sought:** Please provide copies of my APARs for the period from November 2016 to September 2018.

#### CPIO, MANAGE provided information as follows:-

CPIO, MANAGE vide letter No.MNG-01/Admn/RTI-Corrs/05-11/316/29324, dated 5<sup>th</sup> February 2019 provided following information to the applicant:

- Copies of APARs for the period from 16-11-2016 to 31-03-2017.
- Copies of APARs for the period from 01-04-2017 to 31-03-2018.
- Copies of APARs for the period from 01-04-2018 to 04-09-2018.

#### Text of Appeal to the First Appellate Authority, RTI:

I received false information on APARs from MANAGE. I provided details in attached file. Hence, send me the original filled up APAR signed by me for the year 201718 duly evaluated by DG, MANAGE immediately as I am having proof that I have submitted the filled up APAR to DD Admin office.

#### Attached file text:

I received false information in APARs from MAANGE.

However, for the year 2017-18, although I submitted the filled up APARs, DG MANAGE written that, I have not submitted and written on blank APARs. As DG knows that my self-appraisal was better and she cannot justify her allegations, if she writes on filled up APAR 2017-18.

It is also to be noted that the blank APARs given to me by your office did not mentioned the dates of absence without leave sanction, but in the filled up APARs the same information is inserted the for the year 1.4.2017 to 31.3.2018. Please clarify the same.

This shows the mala fide intension of DG.

DG is doing it intentionally even before I joined MANAGE, as she gave only one month time to me to join MANAGE and cancelled my appointment letter and re- advertised the position in newspapers.

After filing RTI (RTI application no. DOA&C/R/2016/50848 dated 3/11/2016 reply file no. MNG - 01/RTI-Corres/05-11/196 dated November 21, 2016) asking why she gave me only one month time, while she gave 3 months to a candidate from NAAARM, she taken back advertisement and reissued appointment letter to join MANAGE.

It shows the DGs bias against me even before my joining at MANAGE due to her own prejudice, which I don't know.

Please search in your office and send the correct APARs. It is also to be noted that, I have a proof that I have submitted filled up APARs to DD(Admin) office.

Hence, send me the original filled up APAR signed by me for the year 2017-18 duly evaluated by DG, MANAGE immediately as I am having proof that I have submitted the filled up APAR to DD(Admin) office.
