Information sought from First Appellate Authority
ACABC subsidy provided to me and just before 4 months as lock in period, NABARD again demanded & Bank sent back. The ACABC subsidy kept up to 32 months & recalled back just four months prior as adjustment is completely unjustified as, I complied all terms and conditions of ACABC. I made huge investment & occurred heavy lose.
Decision
After verification, it is found that the information provided by CPIO is correct, as per your original RTI Application. In the appeal, you are explaining your problem with NABARD which were not in the original application and does not amount to seeking information as covered under the definition of section 2 (f) of the RTI Act. The information not sought for in the original RTI request cannot be raised in appeal as per RTI Act

Hence, the appeal stands disposed.
