Do universities need to get permission from MANAGE for diploma in one year agriculture and agricultural related subjects to be conducted by any Govt. recognized university or Gazette notification number-83 dated 6 February 2017 One year diploma in agriculture or horticulture or related subjects can be done by any government recognized university based on Ministry of Agriculture and Farmers Welfare? Explain its complete details.	National Institute of Agricultural Extension Management (MANAGE) is conducting one year Diploma in Agricultural Extension Services for Input Dealers (DAESI), through various Nodal Training Institute (NTIs) such as Agricultural Technology Management Agency (ATMA), Krishi Vigyan Kendra (KVK), Agricultural Research Station (ARS), State Agricultural University (SAU) etc. as per the DAESI guidelines, 2014 of Government of India. Any Universities or other training/education institutes to act as NTIs for conducting DAESI program developed and implemented by MANAGE have to get the permission from the National Institute of Agricultural Extension Management (MANAGE) through State Agricultural Management & Extension Training Institute (SAMETI). DAESI Certificates will be issued by MANAGE for the successful candidates of DAESI program conducted by such approved NTIs.

If the applicant is not satisfied with the information, you may file an appeal to the First Appellate Authority within 30 days of receipt of reply of CPIO. The name, designation and complete address of the First Appellate Authority of this Institute is as under:-
