I was benefited under AC&ABC scheme as training upto 21/01/2017. Loan application sponsored by MANAGE to Bank branch 24/02/2017. Loan sanctioned and disbursed on 01/03/2017. Subsidy released on 18/11/2018 and subsidy called back on 19/11/2019 by referring letter of MOA&FW, New Delhi No.1(6)/2016-EM, dated 23rd December 2016. Almost after 3 years as retired employees are not eligible for subsidy. Then why Three Years services as AC&ABC received from me under scheme.

## Decision

After verification, I found that the information provided by CPIO is correct based on available records as per your RTI application, and no further information is to be furnished.
