According to notification of Govt. of India one must have (DAESI) Diploma in Agriculture Extension Service for Input Dealers Course to pesticides dealers. In this regard kindly provide me the following information:

Query 1: Whether this notification is also applicable in co-operative society member who sells pesticide/fertilizer/insecticide or not

Reply: As per the Govt. of India Gazette Notification G.S.R.106(E), Dated 01-02-2017 issued by Ministry of Agriculture and Farmers Welfare, a Person who applies for the grant of license to sell, stock or exhibit for sale or distribute insecticides shall possess or employ a person possessing a graduate degree in Agricultural Sciences or Biochemistry or Biotechnology or Life Sciences or in Science with Chemistry or Botany or Zoology from a recognized university or Institute (or) One year diploma course in Agriculture or Horticulture or related subjects from any government recognized university or institute with course content on plant protection and pesticides management.

Query 2: If this notification is not applicable for co-operative society members, then kindly explain the reason of it.

Reply: : As per the Govt. of India Gazette Notification G.S.R.106(E), Dated 01-02-2017 issued by Ministry of Agriculture and Farmers Welfare, a Person who applies for the grant of license to sell, stock or exhibit for sale or distribute insecticides shall possess or employ a person possessing a graduate degree in Agricultural Sciences or Biochemistry or Biotechnology or Life Sciences or in Science with Chemistry or Botany or Zoology from a recognized university or Institute (or) One year diploma course in Agriculture or Horticulture or related subjects from any government recognized university or institute with course content on plant protection and pesticides management.

Query 3: If applicable then which university/Govt. institute do this course

Reply: As per the Govt. of India Gazette Notification G.S.R.106(E) Dated 01-02-2017 any government recognized university or institute with course content on plant protection and pesticides management can offer the certificate course. As per this Clause National Institute of Agricultural Extension Management (MANAGE) is organizing a one year diploma course on Diploma in Agricultural Extension Services for Input Dealers (DAESI).

Query 4: Gurukashi University (Talwandi Sabo Bhathinda, Punjab) is ICAR & UGC Accredited University and Rimt University (Mandi Gobindgarh, Punjab) is UGC approved provided this course. Can any pesticide dealers or co-operative members do this course in both university or not. If no then kindly explain the reason.

Reply: MANAGE is not competent authority to provide/decide information on this.

Query 5: How many States are started this course for co-operative society member who sells pesticide/fertilizer/insecticide.

Reply: At present MANAGE is implementing DAESI program in 20 States through 21 State Agricultural Management Extension Training Institutes through network of Nodal Training Institutes.
