If I want to do diploma in agriculture science from private university in Uttar Pradesh then my certificate is valid for fertilizer and pesticide license or not?

Reply

As per the Govt. of India Gazette Notification G.S.R.106(E), Dated 01-02-2017 issued by Ministry of Agriculture and Farmers Welfare, a Person who applies for the grant of license to sell, stock or exhibit for sale or distribute insecticides shall possess or employ a person possessing a graduate degree in Agricultural Sciences or Biochemistry or Biotechnology or Life Sciences or in Science with Chemistry or Botany or Zoology from a recognized university or Institute (or) One year diploma course in Agriculture or Horticulture or related subjects from any government recognized university or institute with course content on plant protection and pesticides management.

Regarding the validity of the certificate, the information may be sought from the concerned regulatory authority at the Department of Agriculture in Uttar Pradesh

If the applicant is not satisfied with the information, you may file an appeal to the First Appellate Authority within 30 days of receipt of reply of CPIO. The name, designation and complete address of the First Appellate Authority of this Institute is as under:-
