Reply: The course is open to all the practicing input dealers, who have appeared at least for 10th standard exam passed or failed and to candidates sponsored by the input Agencies/agribusiness companies/ agri-cooperatives etc.

Query 3: What was about fee structure in this course all about this diploma program?

Reply: As per the DAESI guidelines, Under CSPS scheme the total course fee of Rs. 20,000 will be subsidized by DAC and FW (Department of Agriculture Cooperation and Farmers Welfare) Govt. Of India to the extent of Rs.10, 000/- per input dealer. Whereas, for non-licence holder who enrolled under Self Finance scheme is to be paid Rs. 20,000/- per candidates.
