As per the Advertisement i.e., Advt.no: F.no. MNG-01/Admn-363/2020-21/vol.II, It is clearly mentioned that the examination pattern for the combined written examination for both the positions of Junior Technical Assistant (Network Administration) under UR category and Junior Technical Assistant (Training) under ST category is same.

But it is not mentioned anywhere in the notification that the same person can appear for two post code exams at the same time. It is the candidate choice to choose one among the two post codes exam he want to write, how he can attend two post code exams at the same time and how he can attend skill test for two post code exams at the same time.

The same person got selected under ST category how he can be put in wait listed candidates list in other post code under UR category I am kindly requesting you to please give information regarding this matter and do the justice so that needful people will get the opportunity.

I Meghavath Shravan Roll no: TR27. Post code: Junior Technical Assistant (Training) under ST category placed in 2nd position in written examination and performed well in the skill test and having experience but i am placed in wait listed candidate 1. I want to know my written examination marks and skill test marks.

As per job notification Sl.No. 3 position is Junior Technical Assistant (Network Administration) UR category

SI.No.4 position is Junior Technical Assistant (Training) ST category

As per Government rules, any reserved candidates can apply for the Un Reserved positions, if he fulfils qualifications & eligibility conditions.

In the MANAGE website notification it is clearly mentioned in the general conditions that candidates who are applying for more than one post should pay the prescribed fees separately and are required to fill up separate application for each post. The person who got selected under ST category and waitlisted in UR category has submitted separate application for each post and later got shortlisted based on his performance in written & skill test.
