The candidates, not having agri-input license/ not sponsored by any input company/organization will be trained under DAESI through self-finance mode by paying the entire course fee of Rs.20,000/
2.	Is the DAESI Course certificate valid in any state of India?	The certificate is valid across the country in any state of India.
3.	If I do a DAESI course from SGT University in Haryana, Gurgaon, can I apply for a fertilizer license in Tripura with the certificate?	Contact state Department of Agriculture, Tripura for issue of fertilizer license, as the said course does not relate to DAESI.
4.	Within how many days of completion of the course is the certificate given?	Within 45-60 days after the completion of final examination of DAESI.
