This is with reference to your online RTI application cited above, requested MANAGE to provide information under RTI Act, 2005. The information sought is furnished below:-

Information sought	Reply
A. Question Paper Vetting: Provide a certified copy of the Official Blueprint or Syllabus Mapping Report used for the UDC exam held on 18/03/2026. This should include the topic-wise distribution of marks approved by the competent authority.	The requisite information sought by the applicant is not available with this office.
B. Deviation Records: Provide a copy of any internal file notings or instructions issued to the paper-setting agency that authorized the inclusion of 100% Data Interpretation questions within the Reasoning section, and the omission of Polity and History (Ancient, Medieval, Modern) from the GK/GA section.	The appellant is informed that preparation of questions is a time consuming job, which is being done by our officers in addition to their normal official assignments. Since the question bank and its answer key for setting the question papers have acquired the nature of intellectual property of this institute, the disclosure of which to one person would harm the competitive position of other candidates. Hence, copies of question papers and its answer key are exempted from disclosure as per section 8(1) (d) of the RTI Act, 2005.
C. Objection Management Policy: Provide a copy of the Standard Operating Procedure (SOP) or Departmental Rules regarding the process for candidates to raise objections against incorrect questions or answer keys for recruitment exams.	The requisite information sought by the applicant is not available with this office.
D. Transparency Protocols: Provide a copy of the Rules/Policy documents that justify the practice of declaring final results without the prior publication of a provisional answer key and a window for candidate objections.	The requisite information sought by the applicant is not available with this office.
E. Junior Stenographer Records: Regarding the Junior Stenographer recruitment under the same notification (01/2025), provide the official grounds/record for not uploading the question paper and answer key on the official website before the declaration of results. Note: As per Section 2(j)(i) of the RTI Act, 2005, if providing these documents digitally is not feasible, I hereby request a scheduled date and time to personally visit your office to inspect the relevant recruitment files and records.	The official grounds / records for not uploading the question paper and answer key is not available with this office. Recruitment files and records are confidential in nature and cannot be disclosed. Hence, the information sought by the appellant is not permissible to provide under Section 8 (1) (d) of the RTI Act, 2005.
