IV. Selection Criteria for the post of Junior Stenographer :

- Each question in paper I carries **one** mark and there will be negative marking of **0.25** for each wrong/incorrect answer.
- Top 6 candidates each from OBC and ST category in Stage – I exam will be called for skill test i.e., Shorthand English Lower (80 WPM) and Typewriting in English Lower (30 WPM) tests.
- Written Examination will be conducted on pen and paper mode.
- Final Merit list for the post of Junior Stenographer will be prepared based on the combined marks secured in the written examination and Shorthand test subject to qualifying in Typewriting test.
- If two candidates get equal marks (tie cases), candidate having desirable qualifications/experience will be placed higher. In case, desirable qualifications/experience are also the same, candidate with earlier Date of Birth will be ranked senior to those having later Date of Birth and even if the qualifications/experience and date of birth of Tied candidates is same, a re-test of the tied candidates will be conducted.

- No correspondence will be entertained from the candidates regarding syllabus of Written Examination and Final Appointment.
- MANAGE reserves the right to modify/withdraw/cancel any communication already made to the candidates.**
